**1. Approval of Minutes (Lawson Fite)**

**2. Chair's Report (Patrick Rowe)**

Reminder to submit nominations for state bar awards, as stated in email of April 22. The deadline is July 14 and nominations should be submitted to Kay Pulju.

**3. Bar Liaison Report (Stacy Owen)**

Nothing to report beyond that covered in Chair's report.

**4. Treasurer's Report (Dustin Till)**

\$10 in revenue and \$193 in expenses for April. Balance is \$12,101. Currently have 502 paid members and 510 total members. Last year at this time, total membership was 513.

Patrick asked how our membership compared to other sections. Stacy stated that this is on the high end. Lawson noted that ENR is larger than Ag and much larger than Aviation. All agreed that ENR is likely smaller than Litigation.

**a. Updating ENR deskbook (Kirk Maag)**

Karen reported that volume 2 is still sitting due to two authors (CERCLA and environmental insurance) who have not finished their chapters. Pressure is being put on those authors and we expect progress soon.
